



ED-RED

SB3606 (Loughran-Cappel): **Equalization of High-Cost SpEd Funding**

- Equalizes reimbursement rates for public placements • Amount in excess of 2 times the district's per capita tuition charge is eligible for reimbursement from the State • Same rate as private placements



HB4709 (Hirschauer)/SB3383 (Villivalam) **Deprioritization of School Polling Places**

- Requires the consideration of other public buildings prior to requesting the use of a school building
- Requires approval of the school board before a school building can be used for polling






