17 Session Days Scheduled in April Weekly Friday Deadlines Bill Trends



## SB3606 (Loughran-Cappel): Equalization of High-Cost SpEd Funding

- Equalizes reimbursement rates for public placements
- Amount in excess of 2 times the district's per capita tuition charge is eligible for reimbursement from the State

Same rate as private placements

#### **UPDATE:**

Passed - Senate Education Committee 13-1 Heading to the Senate for a full vote

## HB4709 (Hirschauer)/SB3383 (Villivalam) Deprioritization of School Polling Places

- Requires the consideration of other public buildings prior to requesting the use of a school building
- Requires approval of the school board before a school building can be used for polling

#### **UPDATE:**

No path forward with clerk opposition Regrouping with sponsors on other approaches

## HB2822/HB3991 (Crespo): Supporting Newcomer Students Program

- Amendments Filed
  - Aligning Language to ISBE's Recommendation
  - \$188M = ED-RED, CPS, DuPage & South Cook
  - Guardrails for the proportionality of the distribution of funds for CPS and Non-CPS Districts



## HB5020 (Blair-Sherlock): Dual Credit Quality Act

- Amendment 1
  - Partnership Agreements
  - Creates Dual Credit Committee
  - Consistency in qualifications for Dual Credit Teachers



### HB3907 (Stuart): Teacher Plan Time

- Amendment 1 Filed
  - Requires all teachers or "clinicians" in contact with students at least 50% of the day to be provided dutyfree, self-directed plan time
  - An alternative plan time schedule can be locally bargained but without an agreement, the default will be 45 minutes a day
  - The relinquishment of this time shall be compensated

## HB4622 (Didech): Local School District Mandate Note

- Amendment Pending ISBE
  - Create a committee structure to review proposed mandates
  - ED-RED 2022/23 Initiative: "Mandate Review Committee"



### HB4902 (Faver-Dias): Literacy Plan Material Alignment

 Requires all vendors and/or learning partners approved by a school district to support their continuous improvement plan for language arts/English to be based on the comprehensive literacy plan



### SB3166(Koehler)/ HB5275(Ness): Student Records

- Requires information regarding a student's IEP/504 to be included in permanent record
- Aims to ensure the age of which a disability surfaces can be proven for adult services
- Amendment Drafting: What can/cannot be included on permanent records; storage requirements on local districts


